Initial support for the region involved recovery and immediate protection of the survivors. Bridge to Turkiye support was in the form of basic survival needs such as tents, blankets, beds, warmth, water, food and providing basic sanitary conditions.

**Explanation:** Bridge to Turkiye, changed its Fiscal Year to close on June 30, 2022. This resulted in a short-year filing for Bridge to Turkiye from January 1, 2022, to June 30, 2022. We used 2022 Tax Forms for 990 for the short-year filing. With this, our operating assumption was that the next fiscal year 990 filing would be labeled as a 2023 Tax Filing, starting on July 1, 2022, and ending on June 30, 2023. As we are now filing for this period, with an automatic 6-month extension requested, we understand that we must file by reusing 2022 Tax Forms for 990. For this reason, we are submitting the Fiscal Year July 1, 2022, to June 30, 2023, using 2022 Tax Forms for 990. This should get Bridge to Turkiye back to the expected cadence from the IRS. This was an oversight on the part of management due to the Fiscal Year transition.
